

MEETING MINUTES PORT HOPE PUBLIC LIBRARY BOARD MEETING Mary J. Benson Branch 31 Queen Street Port Hope, ON May 12, 2025 (rescheduled from May 5, 2025) 4:30 p.m.

Bob Wallace, Chairperson called the meeting to order at 4:30 p.m. noting a lack of quorum. The meeting would proceed without approved actions.

- 5.1 Port Hope Community Hub
- 5.1.1 Building renovation
 - The CEO provided an update regarding the renovation of the lower level of the site and confirmed that the Hub Branch had reopened on May 12 after a six-week closure.

5.1.2 Hub branch review committee

- The link for the library survey has been posted to the library website. Committee
 members requested board member support and participation in distributing
 flyers, encouraging residents to complete the survey and possibly lead or
 participate in one of four different focus groups. As materials are checked out at
 Mary J. Benson library staff are asking patrons whether they are aware of our
 second branch in Canton. To date the responses, indicate that at least 80% of
 individuals are aware of the location of the Hub Branch.
- 5.2 Presentation to Municipality of Port Hope Council
 - The CEO reported that the next possible council meeting date for a presentation would be June 17, 2025. Several suggestions for topics included the Hub Branch review, 2024 annual report and the Friends of the Library fundraiser for the refresh of the children's area at Mary J. Benson. Members interested in developing the 10-minute presentation are to contact the CEO.

 - B. Wallace reported that interviews had been held at the end of April. A recommendation from the interview panel comprised of the chairperson, Susan Jones Bouk and the CEO has been forwarded for the consideration of Council at its council meeting on May 20 2025.
